- **One-click Screenshot Translation:** Performs OCR recognition on user-selected screen areas for English content.
- **Bilingual Translation Analysis:** Generates side-by-side Chinese-English translation results.
- **Pronunciation Support:** Provides American phonetic notation and human-like pronunciation.
- **AI Speech Evaluation:** Uses the microphone to receive user speech and provides pronunciation scoring.

2. Usage Rules

- **Prohibited Uses:** Must not be used for illegal purposes such as cracking copyrighted content or exam cheating.
- **Device Permissions:** Screenshot functionality requires screen access authorization; speech evaluation requires microphone authorization.
- **Content Compliance:** User-submitted content must not contain illegal information or infringe third-party rights.

- **Screenshots:** Original images are never uploaded; only extracted text is processed, with cache immediately deleted.
- **Voice Data:** Microphone recordings are analyzed in real-time during evaluation only; never stored or transmitted.
- **Text Data:** Translated content is transmitted via TLS 1.3 encryption; server-retained data is anonymized.

3. Third-Party Sharing

- **SpeakCheck Engine:** Receives anonymized text data as the core technology provider for translation services.
- **Google Analytics:** Collects basic usage statistics (can be disabled in settings).
- **Zero Advertising Partnerships:** User data is never shared with advertising platforms.

4. User Rights

- **Data Deletion:** Clear historical translation records via one-click option in plugin settings.
- **Permission Control:** Disable screen/microphone permissions anytime via browser extension management.
- **Opt-Out of Profiling:** No creation of personalized profiles based on user behavior.
